### Section A: Eligibility Requirements

ACU offers the Christian Academy Discount for the Fall and Spring terms each academic year for 8 consecutive semesters. This award is not available for the Summer terms. To be eligible for this award, prospective recipients must meet the following requirements:

- Apply for and be granted admission to ACU
- Submit this Christian Academy Tuition Discount application by March 1, before the Fall semester
- Enroll in and complete a minimum of 12 hours per semester
- Be age 25 or under at the beginning of each Fall semester
- Be working on his/her first undergraduate degree
- Their parent(s) must have been employed full time by a Christian Academy for at least **12 months prior** to the date of ACU enrollment to receive this discount
- The Christian Academy must be a member of the National Christian Schools Association or be approved by ACU

### Section B: Renewal Provision

ACU will renew the Christian Academy Tuition Discount to students after their first year at ACU if they continue to meet the following requirements:

- Maintain a minimum cumulative 2.0 GPA, beginning with their first semester
- Enroll in and complete a minimum of 12 hours per semester
- Submit this Christian Academy Tuition Discount application by March 1, before the Fall semester
- Be age 25 or under at the beginning of each Fall semester
- Be working on his/her first undergraduate degree
- Their parent(s) must have been employed full time by a Christian Academy for at least 12 months prior to the date of ACU enrollment to receive this discount
- The Christian Academy must be a member of the National Christian Schools Association or be approved by ACU

### Section C: Award Amount (Please Note)

The Christian Academy Tuition Discount is a guarantee of **25 percent of tuition** for dependents of Christian Academy employees and 50 percent of tuition for dependents of the superintendent, CEO or principal of the Christian Academy **when coordinated with Federal, State and other Institutional aid.**
